Re: EnergyConnect (NSW – Western Section) (SSI-10040) – Proposed use of an additional water supply point on Modica Crescent, Buronga

I refer to EnergyConnect (NSW – Western Section) (SSI-10040) (the Project), which the NSW Minister for Planning and Public Spaces approved on 28 September 2021 pursuant to section 5.19 of the NSW *Environmental Planning and Assessment Act 1979*.

This letter seeks the Planning Secretary's concurrence to use a water supply point at Modica Crescent, Buronga, and associated water supply route that the Infrastructure Approval does not currently contemplate explicitly.

Transgrid intends to commence construction initially in the vicinity of the existing electricity substation on Arumpo Road, Buronga, with the following activities:

- commencement of the upgrade of the existing substation at Buronga, and
- establishment of the accommodation camp and construction compound adjacent to the Buronga substation upgrade work area.

Site establishment and earthworks activities at Buronga require raw water (for example, for compaction, dust suppression, etc.). The accommodation camp needs a supply of potable water.

Table 2-3 and Figure 2-12 of the Amendment Report identify the proposed water supply points for the Project. The table and figure identify only two potable water supply points for the Project: River Drive, Buronga and Beverley Street, Wentworth. However, the Amendment Report incorrectly identifies the supply point at River Drive, Buronga, as a potable water source. In reality, it supplies raw water.

Wentworth Shire Council (Council) owns the potable water supply points in this area. Transgrid's construction contractor, SecureEnergy, is currently discussing potable water supply for Stage 1 with Council. During the discussions, Council identified an option to use an existing hydrant on Modica Crescent, Buronga, for potable water supply. Attachment 1 to this letter identifies the proposed potable water supply point on Modica Crescent, Buronga, and the associated water supply route. Attachment 2 provides email correspondence from Council (dated 27 July 2021) identifying the water supply point on Modica Crescent as a preferred location.

Transgrid notes that Modica Crescent connects to Corbett Avenue, which then connects Alcheringa Road. Appendix 2 to the Infrastructure Approval already identifies Corbett Avenue and Alcheringa Road as a Project water supply route to a raw water supply on Alcheringa Road, Buronga (refer to Attachment 1). Therefore, accessing the proposed water supply point on Modica Crescent would mainly use an existing Project water supply route.

SecureEnergy might access the proposed water supply point on Modica Crescent at peak construction up to five times per day. Modica Crescent is sealed, minimising the potential for dust emissions. Transgrid notes that the land adjacent to Modica Crescent is zoned IN1 General Industrial. There are no sensitive receivers adjacent to Modica Crescent. As a result, the use of the Modica Crescent water supply point has negligible potential to affect the amenity of any additional sensitive receivers.

Transgrid notes that using the approved water supply point in Beverley Street, Wentworth, would involve truck access along Sandwyck Street, Beverley Street and Helena Street, which are all local roads through a residential area. Based on potential amenity impacts to sensitive receivers, using the proposed water supply point on Modica Crescent is preferable to using the approved water supply point on Beverley Street, Wentworth. On this basis, Transgrid believes that the use of the proposed Modica Crescent water supply point would be consistent with the Project as approved.

Transgrid notes that Condition D36 potentially limits the use of roads for water supply to only those water supply routes identified in Appendix 2 to the Infrastructure Approval. Condition D36 b), however, indicates that the Planning Secretary has discretion regarding water supply routes. Accordingly, Transgrid requests that the Planning Secretary allow the use of Modica Crescent as a water supply route for the Project, subject to:

- addressing the use of Modica Crescent in the Traffic Strategy required by Condition D37
- implementing any required road upgrades to Modica Crescent in accordance with Condition D38
- carrying out dilapidation surveys along Modica Crescent in accordance with Condition D39, and
- addressing the use of the Modica Crescent water supply route in the Traffic and Transport CEMP Sub-plan prepared in accordance with Conditions D40, B2 and B6.

Transgrid has commenced consultation with Council and Transport for New South Wales regarding the use of the roads, the Traffic and Transport CEMP Sub-plan and the Traffic Strategy. Transgrid would greatly appreciate the Department's earliest possible consideration of this request.

Going on your figures of a maximum of two 55,000ltr Road Train tankers a day, we can't see a problem with supply.

Accessing the water kiosk at Gol Gol will pose a problem for road trains due to its location on a side road.

Would it be possible for you to draw everything from Wentworth, as we have road train access to the water kiosk at that point?

If not, we can arrange a metered hydrant to access a hydrant point in Buronga.

We will need to set your company or the haulage company up as debtor so our Wentworth office can arrange a "water card" for you to access the kiosk,

Council charges \$1.25 per Kilolitre.

If that all works, let me know and we will get the paper work organised.

Hi Allan,

Many thanks for the meeting this afternoon.

As discussed, we would be grateful if you could confirm if the quantities of potable water detailed in the enclosed spread sheet can be supplied by Wentworth Council to our camps / laydowns.

Ideally the total required is met by Wentworth Council but if that is not possible, any quantity is great with the preference for GoI GoI to supply Camp 6 and Wentworth to Camp / Laydown 7.

As discussed, while camp 6 is larger (340 beds and 60 desk office), Camp 7 (160 beds and 30 desk office) also has a mobile batch plant that will require 350/m3 of concrete.

Can you also confirm your contact at Lower Murray Water for us so as we can speak to them about potable water supply as well (assuming you cannot supply the quantities required).
