

# Powering Sydney's Future

## POTTS HILL TO ALEXANDRIA TRANSMISSION CABLE PROJECT COMMUNITY NOTIFICATION

### Underbore at Rawson Road, Greenacre

TransGrid is installing a new underground electricity cable from Potts Hill to Alexandria. The Powering Sydney's Future project will help ensure a safe, reliable and affordable energy supply for Sydney's CBD and surrounding areas. Work to drill an underbore at **Rawson Road, Greenacre, at the intersection of Illawong Crescent**, is due to start from week commencing **Monday, 28 September 2020** and will take around four weeks, weather and ground conditions permitting.

We will set up two site compounds on Rawson Road, on either side of Illawong Crescent (see map overleaf).

#### Work activities

- > Installing temporary fencing and safety barriers.
- > Drilling under the road using a drill rig located in the eastern site compound.
- > Excavating a pit in the western site compound.
- > Pulling conduits (plastic pipes) through the underbore.
- > Temporarily restoring the road surface to allow normal traffic flow.

Our team will return at a later date to undertake trenching work along Rawson Road. Permanent restoration of the road and any impacted areas will take place after the new cable has been pulled through.

We will write to you again before these next stages of work.

#### Work hours

Standard work hours are **7am – 6pm, Monday to Friday** and **8am – 1pm on Saturdays**.

#### How will the work affect you?

- > The work will generate some noise, which we will make every effort to keep to a minimum.
- > There will be a temporary loss of street parking while work is in progress.
- > There will be temporary lane closures to ensure the safety of workers and road users, although two-way traffic flows will be maintained. Traffic control will be in place to safely direct traffic around the site.
- > Access to properties will be maintained unless we make alternative arrangements with you in advance.
- > Limited tree trimming may be required to create a safe distance from plant and equipment. This work will be conducted by a trained arborist.

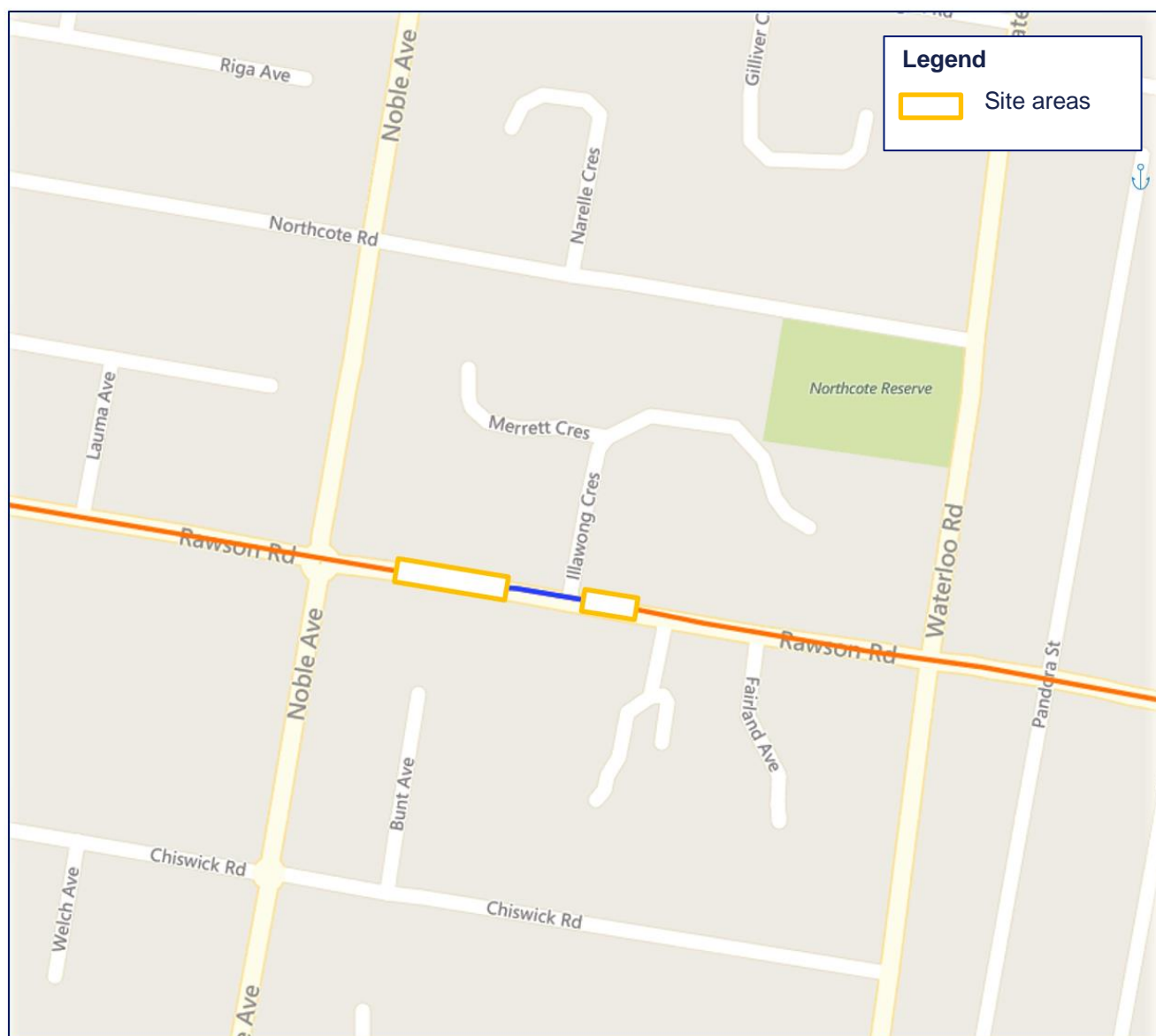
