# HumeLink Community Newsletter



October 2024

HumeLink is one of Australia's largest energy infrastructure projects connecting renewable energy sources to the grid, increasing availability and market competition - helping to put downward pressure on energy prices in Australia.

The project consists of 365 kilometres of 500 kV overhead transmission lines connecting Wagga Wagga, Bannaby and Maragle, and new or upgraded infrastructure at four substations.

HumeLink is critical to bringing more affordable, reliable and renewable energy to the grid and is a priority project for the Australian Energy Market Operator (AEMO) and the Commonwealth and NSW governments. Subject to government approval of HumeLink, the proposed construction will occur in two sections known as HumeLink East and HumeLink West.



# **Project update**



# HumeLink enabling works and construction timeline

When planning approval is granted for a Critical State Significant Infrastructure project such as HumeLink, the next step is to receive the NSW and Commonwealth Ministers' Conditions of Approval. These outline the requirements for the project's next stages.

The Conditions of Approval inform the Construction Environmental Management Plan (CEMP), which is submitted to the NSW Department of Planning, Housing and Infrastructure (DPHI) for approval before main construction begins.

## What are the next steps?

#### **Preparatory works**

Preparatory works would take place following project approval and in parallel with the development of the CEMP.

These works include:

- installing erosion and sediment control measures to reduce soil erosion, such as detention basins (surface level basins which store water run-off)
- biodiversity surveys and archaeological testing
- dilapidation surveys and investigative drilling.

#### Site establishment and enabling works

After preparatory works, site establishment and enabling works works will take place. This involves laying down the foundations for main construction.

These works include:

- Limited vegetation clearance to help set up access tracks, construction compounds, worker accommodation facilities and other ancillary facilities
- Setting up services and utilities such as water supply points
- Building access tracks and associated minor waterway crossings to allow construction machinery and vehicles to safely travel between project work sites. Waterway crossings will be reviewed on a case-by-case basis and avoided where possible
- Road improvement work to ensure heavy vehicles travel safely between work sites
- Establishing worker accommodation facilities and construction compounds.

An Enabling Works Management Plan (EWMP) has been developed to describe how these works will be managed, and this was submitted to the DPHI as part of the planning approval process.

## The EmPOWERing Regional Women Program kicks off in Yass

HumeLink East has launched its innovative pre-employment program aimed at increasing female participation in the construction industry, with a specific focus on Yass and surrounds.

A diverse group of 17 women have commenced the program, and over seven weeks they will be upskilled with fully accredited training and supported with initiatives like mentoring, resume writing, interview skills and a wellbeing program.

The program is a great step towards diversifying the workforce and creating opportunities for regional women. It has been made possible through a grant from the NSW Government, Women in Constructions Industry Innovation Program.
