The dam is full of tracks, scats and traces, numerous animals come and go from the area. The dam is also excellent bell frog habitat. No threatened species were seen during survey.

The area has dense clay soils which is preferred by the threatened Chariot Wheel (Maireana cheelii), and Slender Darling Pea (Swainsona murrayana). Both species were found near by in original surveys. We are out side the regular survey period for both species

State significant weeds are present. Thistles like Scotch Thistle (Onopordum acanthium) and Star Thistle (Centaurea calcitrapa) are diffuse through the area.
