

# Mount Piper to Wallerawang Transmission Line Upgrade Project Community Newsletter

September 2024

#### **Project overview**

Transgrid is proposing to deliver a new 330kV (kilovolt) transmission line that is approximately 8km in distance, and between existing substations at Mount Piper and Wallerawang. The new transmission line is within the local government area of Lithgow and on the lands of the Wiradjuri people.

The project will carry out upgrades to our transmission network in the State's Central Tablelands to support the NSW Government's delivery of the Central-West Orana Renewable Energy Zone (REZ). These upgrades will strengthen and reinforce the grid in the Central Tablelands, helping to ensure that power from the Central-West Orana REZ can be reliably moved back into the grid and to consumers.

**Cheaper electricity** – improving the affordability of electricity for consumers by increasing supply and driving down electricity prices




**Improved reliability** – delivering large amounts of new energy and strengthening and reinforcing the grid in the local region

# **CSSI declaration**

On 3 July 2024, the project was declared Critical State Significant Infrastructure (CSSI). CSSI projects are declared when a project is essential for NSW for economic, environmental and social reasons. All CSSI project applications must be accompanied by an Environmental Impact Statement (EIS). The local community and other key stakeholders will be able to provide feedback on the EIS during the public exhibition period. This will take place in early 2025 and the project team will consult widely during this period to ensure stakeholders can actively participate in the process. # **EPBC referral declaration**


Transgrid submitted a referral under the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). The EPBC Act is Australia's main environmental law and provides a legal framework to protect matters of National Environmental Significance. The project has been decided as a 'controlled action' and will need Commonwealth approval. The referral can be viewed <u>here</u>.

# SEARs

On 24 July 2024, the Department of Planning, Housing and Infrastructure (DPHI) issued the final Secretary's Environmental Assessment Requirements for the project. ## Lithgow & District Family History Society Inc.

Last month Transgrid's Community Engagement Officer, Prudence Inwood, visited the Lithgow & District Family History Society Inc. The organisation was a proud recipient of a Transgrid grant in late 2023. Prue had the pleasure of meeting Eleanor Martin, a founding member and current President of the society, who discussed the positive impact the funding will have on their work in Lithgow and surrounding regions.

Since its establishment in 1986, the society has been pivotal in preserving and documenting the rich heritage of Lithgow and its surrounding regions. With members spanning local, interstate, and international locations, the society is dedicated to unearthing and safeguarding local family history.

The society has made commendable efforts in the field of research for publications including 'A Long March from Lithgow', a book comprised of records, letters and information about those who lived or enlisted in the Great War from the Lithgow region. Additionally, their collection of physical artifacts offers a tangible link to the past, from a meticulously crafted replica of the Black Pearl Ship made by a former member to a flag waved by a local woman in 1954 as Queen Elizabeth II visited Lithgow.

The CPP grant allowed the society to purchase much-needed equipment including new desks, large computer monitors, and ergonomic office chairs. "We received two new desks, five new large monitors, and all of our workers now have a new ergonomic chair which has made a vast difference," Eleanor said. "We're so used to second hand furniture it was lovely to receive something new."

The new resources have substantially improved the society's working environment, directly benefitting the dedicated members who work to preserve and share the community's rich heritage.
