#### What is HumeLink?

HumeLink is one of Australia's largest energy infrastructure projects connecting renewable energy sources to the grid and increasing availability and market competition - helping to put downward pressure on energy prices in Australia.

The project consists of 365 kilometres of 500 kV overhead transmission lines connecting Wagga Wagga, Bannaby and Maragle, and new or upgraded infrastructure at four substations.

HumeLink is critical to bringing more affordable, reliable and renewable energy to the grid and is a priority project for the Australian Energy Market Operator (AEMO) and the Commonwealth and NSW Governments. HumeLink is subject to the approval of the Australian Energy Regulator.





Figure 1: HumeLink preferred route.





#### Transgrid Discovery Hub is officially open

More than 600 people visited the Transgrid Discovery Hub for its opening on 16 April 2024. Thank you to everyone who joined us for this celebration.

Community members were invited to participate in interactive workshops featuring local Indigenous weaving, tours of the Hub, face painting and presentations.

The Discovery Hub is a first of its kind for Transgrid, offering a consistent and accessible point of connection with community, landowners and businesses in the surrounding areas.

Visitors can engage with Transgrid and access information about our energy vision, major projects, operations and community-based activities at the Hub. There is a discovery space designed for schools and community members to explore the key concepts surrounding energy, engineering, and the environment. A program is currently being developed with educational professionals to provide class learning resources for secondary students.

There is also a community share space, designed to host community and visitor meetings and workshops.



#### Amendment Report and Submission Report lodgement

Following the public exhibition of the HumeLink Environmental Impact Statement (EIS) in September and October 2023, the NSW Department of Planning, Housing and Infrastructure (DPHI) provided Transgrid with the submissions it received. Since this time, Transgrid has been reviewing submissions and preparing responses to the issues raised. We are currently finalising the Submissions Report, which collates, categorises and responds to the submissions received on the EIS.

A number of proposed project amendments and refinements were identified in response to issues raised in submissions on the EIS, including construction and design refinements. These will be assessed and reported in an Amendment Report.

Based on our current program, these reports will be lodged with the DPHI this month. Certain components of these reports, including the Revised Biodiversity Development Assessment Report and other information related to biodiversity (such as updated environmental mitigation measures and the response to the Biodiversity, Conservation and Science Directorate submission on the EIS) will be lodged with the DPHI in June 2024. Both the Amendment Report and the Submissions Report will be publicly available on the NSW Major Projects Planning Portal.



#### Frequently asked questions

#### What's in HumeLink's Amendment Report?

HumeLink's Amendment Report outlines project changes since public exhibition of the EIS, and helps the community, government agencies and DPHI understand the implications of these changes.

The HumeLink Amendment Report assesses several amendments and refinements made following feedback from stakeholders before and during the public exhibition of the EIS, as well as design and construction methodology development by the project's delivery partners. A number of technical reports have also been prepared to support the assessment of the proposed amendments and refinements. These will be appended to HumeLink's Amendment Report .

### How does the Amendment Report fit in with the environmental planning approvals?

The Amendment Report will be reviewed and assessed by the DPHI alongside the Submissions Report and the EIS. The DPHI will then make a recommendation to either approve the project along with any conditions or provide reasons for refusal.

HumeLink requires approval from both the NSW and Commonwealth governments to proceed with construction.

#### **HumeLink On-Country immersion**

Transgrid and the HumeLink East team, led by our HumeLink East delivery partner Acciona Genus Joint Venture (AGJV), were invited to on an On-Country cultural immersion during a recent visit to Ngunnawal Country in Yass.

Ngunnawal Traditional Custodians shared stories and information about the culture and history that have shaped the Ngunnawal people's identity for generations.

The immersion deepened the team's understanding of our connection to Country, through cultural tours and visits to significant sites over a few days.

A specially commissioned artwork by proud Wiradjuri man Luke Penrith was unveiled during the visit. This artwork encapsulates our vision of integration between our project team, the community, transmission towers and landscape. The work represents our continuous commitment to respectful engagement and harmonious coexistence with the local environment and culture.
