





#### **TAC purpose statement**


To inform and challenge Transgrid's investment in the transition to clean energy infrastructure to help ensure prudent, efficient and fair outcomes for consumers, customers and communities.

- Provide input and feedback on emerging issues, projects and proposed solutions







### Who we heard from

- 48 written submissions
- 3 town hall meetings attended by 150 people
- 12 community drop-in sessions attended by 50 people
- Approximately 42 landowner meeting/calls
- 6 briefings with government agencies and renewable developers








### Preferred Route identified in Preferred Route Report

Original 'Trumpet' at border




New 'Trumpet'

The adjustment to this area narrows to align better with Victoria's TCV, while broadening at the northern section to allow for additional optionality for the route alignment crossing the border.




### Changes around the township of Moulamein



The distance from the township has been increased to approximately 6km to the north and the route has been widened to allow for additional investigation.



### Realignment of the route north of Wanganella



This realignment to the west of the Cobb Highway at Wanganella results in a shorter line length and increasing the distance between the line and residential properties to the south of Wanganella-Moulamein Road.




### Widening of the route west of Dinawan




After discussions with renewable project developers in the area, the route has been widened for additional flexibility navigating this area.

### Regulation

#### Key updates

#### HumeLink CPA2

- 176 detailed questions received to date from the AER via information requests. Common themes were risk costs, contingency, delivery delay scenario to 2029, MCC, biodiversity and social licence
- EMCa (AER Consultant) All Day Workshop
- <u>Material Change of Circumstance (MCC)</u> Option 3C remains the preferred option - 10% ahead of option 2C with over \$1 billion worth of benefits
- <u>Capital Expenditure Sharing Scheme (CESS) Report</u> Independent CESS report provided to the AER reinforcing:
  - CESS is not applicable for large projects
  - Contractor and Transgrid still have incentive to deliver the project efficiently via contractor model and Ex Post review

#### VNI West CPA1

- 129 questions received from the AER via information request. Common themes were risk costs, contingency, PEC enhancement and Gugga Integration, biodiversity and social licence.
- CPA is at decision stage. The AER has verbally indicated:
  - Reductions/Deferred cost to CPA2 to Risk Contingency, Biodiversity and Social Licence

#### Upcoming :

#### **Central West Orana REZ**

- Consumer Trustee Authorisation expected mid 2024
- Can consult once project has been authorised



### **Regulatory Policy**

#### Key updates on AEMC rule changes

#### **Financeability and Concessional Finance**

- AEMC published final rule determinations on 21 March (largely consistent with the drafts)
- The AEMC's financeability rule falls short as it does not provide the level of predictability and investor confidence that the AEMC intends. We will engage with the AER on the development of its Financeability Guidelines (to be in place by the end of the year)

#### Improving Workability of the Feedback Loop

- AEMC published final determination on 7 March
- Final rule allows for concurrent feedback loop and CPA assessment and requires AER to establish a feedback loop exclusion window

#### **Enhancing R1 Connection Process**

- AEMC released a draft determination on 7 March
- We broadly support this decision which provides incremental improvements to the existing process. Submissions due 18 April

#### **Improving Security Frameworks for the Energy Transition**

- AEMC published final determination on 28 March
- Key outcomes for Transgrid include co-optimised inertia/system strength frameworks and improved TNSP recovery frameworks for non-network security costs

#### Recent submissions available on our website

- AEMO Draft 2024 ISP 16 February
- Commonwealth consultation on introducing New Vehicle Efficiency Standards – 4 March
- Commonwealth Senate inquiry into the transition to electric vehicles 22 April
- AEMC consultation on transmission ring-fencing framework draft determination 4 April
- AER consultation on STPIS framework 5 April

#### Flexibility in Allocation of Interconnector Costs

AEMC published consultation paper on 14 March on a rule change to introduce greater flexibility in allocating costs for critical interconnector projects. Submissions due 11 April

#### Non-Network Solutions (Transgrid driven)

- Rule Change 1 focused on cost recovery timing and certainty issues to be submitted to AEMC imminently
- Rule Change 2 being progressed internally, planning next engagement with TAC on developing positions

#### **Emissions Reduction Objective in the NEO**

- AER consultation to begin shortly on relevant guideline updates (eg. CBA and RIT-T guidelines)
- <u>AER & AEMC</u> published updates on value of emissions reduction interim values (\$66 in 2023 to \$420 in 2050 onwards (AUD2023)) and guidance
